ARA Trust Management (Suntec) Limited, a wholly owned subsidiary of ARA Asset Management Limited ("ARA"), transferred 36,577,801 units to ARA Real Estate Investors XIII Limited, a wholly owned subsidiary of ARA.

As a result, ARA and its wholly-owned subsidiaries, namely ARA RE Investment Group (S) Pte Ltd, ARA RE Investment Group Limited, ARA Investors II Limited, ARA Real Estate Investors XII Limited and ARA Real Estate Investors XIII Limited, collectively hold 6.83% of the voting rights in Suntec REIT. ARA Asset Management Limited is a wholly-owned subsidiary of ARA Investment (Cayman) Limited, which is also a wholly-owned subsidiary of ARA Asset Management Holdings Pte Ltd. ARA Asset Management Limited, ARA Investment (Cayman) Limited and ARA Asset Management Holdings Pte Ltd are therefore deemed to be interested in the units held by its aforesaid subsidiaries.

Total number of units used in the computation of the percentage interest above is 2,661,093,699.
